

Call for nominations for the
2020 Steeples Service to Kansans Award

The Steeples Service to Kansans Award is an annual award that recognizes up to three faculty members at the KU Lawrence campus who provide significant service to the people of Kansas as a purposeful extension to their teaching and research. The award amount is \$1,000. In addition, each recipient will receive a \$1,000 base salary adjustment.

This award was created with three objectives in mind:

1. Faculty who provide significant service to the people of Kansas should be recognized for their efforts. KU has awards for teaching and for research, but this award specifically recognizes intrastate service.
2. KU provides significant service to and for the people of Kansas. These awards will provide a venue for some of that service to be formally recognized on campus, as well as publicized across Kansas in the news media.
3. To encourage faculty to provide service to Kansas by demonstrating the value that the KU administration and promotion and tenure committees place upon such service.

The range of service to Kansas that is performed by faculty from the University of Kansas is too large to give examples of activities that this award is intended to recognize and foster. However, it is explicitly not intended to recognize such activities as reviewing NSF proposals and refereeing articles for well-known national professional journals. It is also not intended to reward service to other State of Kansas agencies, especially if the service is based on contractual obligations between KU and the State agency. However, if an individual's service on such contracts goes far beyond original contractual obligations, or represents innovative or unique approaches, such service should be considered.

Eligibility:

Nominees must hold a full-time University appointment on the Lawrence campus. The selection committee will consider the longevity of service (more than one year of service) as well as the breadth of service (more than a single service project) in their deliberations.

The Support File:

1. The support file must include an up-to-date and detailed curriculum vitae.
2. The nominator should provide the following materials in support of the nomination:
 - a. Department Recommendation. The support file shall contain an evaluation of the nominee from the department chairperson, faculty evaluation committee, or promotion and tenure committee that speaks to the service accomplishments of the nominee.
 - b. Two Letters of Support that document the value of the service from the constituency being served.
 - c. A statement of "Service to Kansas" from the nominee (one page). The faculty member should articulate the outcomes of their service by elaborating on which constituency is being served, what do they get out of it, and evidence that there is some benefit to the constituency being served.
 - d. Other Supporting Materials:
 - i. press releases and media coverage about the service contribution
 - ii. representative documents used during the service performed
